Trending 340B News

- Boehringer Ingelheim becomes the latest manufacturer to announce refusal to ship 340b medications to contract pharmacy locations
 - Will have a large negative effect on our contract pharmacy revenue (approximately 350k per year in potential 340b savings from BI alone)
 - We are now considering potential options regarding sharing data with 340b ESP
- HHS Secretary Becerra says legislation is needed to strengthen HHS' authority to address 340b contract pharmacy pricing denials.
- Arkansas passes unique 340b contract pharmacy law.
 - Law applies to the *acquisition* and *delivery* of 340b drugs, not to pricing.

- Moving forward with Narcan Community Distribution
