Advocacy & Health Policy

Health Center Reauthorization and Funding

- New divided Congress likely to push flat discretionary and mandatory spending
- Strong push planned for Hill Day at NACHC's Policy and Issues Forum on three reauthorization/funding priorities:
 - Expanding the reach of the program
 - Reducing funding gap caused by inflationary pressures
 - Deepening services at health centers
- CHC Congressionally Directed Spending Request (request for earmarked funding)
 - Contingent on new House rules and final funding vehicle
 - Series of in person meetings on the Hill
 - CHC's request is in the FY24 queue with Senator Lindsey Graham



Advocacy & Health Policy

340B Drug Pricing Program

- NACHC:
 - Two in person meetings in DC one with potential collaborative partners
 - Legislative strategy and language in final stages of development and, pending board approval, will be rolled out at P&I Forum
 - Essential that health centers communicate the urgency of meaningful 340B reform during P&I Hill visits
- 340B Working Group (facilitated by Leavitt Partners)
 - In person meeting in DC met with staff for Energy and Commerce Committee and reviewed core principles and framework for reform
 - First draft of legislative language under review
 - Continuing efforts to bring NACHC and the Working Table together as core principles of both groups are well-aligned

State Focus and Activities:

- SCPHCA Legislative Committee meets monthly on the first Friday of each month
- State Policy and Issues Forum held in Columbia
 - Brooke Holloway took lead in CHC representation
- Current state revenue position:
 - Surplus of \$70 million in discretionary funding
 - Surplus of \$2 billion in one-time funds
 - Future loss of revenue due to reduced FMAP



Strategic and Operational Updates:

- Leadership and Staff Development
 - Weekly team meetings/monthly with medical directors included
 - Employee Wellness Program being rolled out
 - Planning underway for in-person Provider Staff meeting in March
- COVID-19 Response
 - Continuing regular email updates
- Funding
 - Consistent, standardized process for funding applications with oversight maintained by Chief Development Officer
 - Two HRSA applications pending Board approval under New Business
 - Dr. Mellette applied for funding from the South Carolina Opioid Recovery Fund to support CCP efforts to reduce opioid deaths in communities served by CHC
 - Governmental Relations Consultant maintaining contact re earmark for Clinton expansion.

 - Department of Pediatrics:
 - Recruitment ongoing for 2 open pediatrician positions
 - Department of Family Medicine:
 - Participating as a Designated Collaborating Organization with Beckman Center for Mental
 Health in their implementation of a Certified Community Behavioral Health Center a national
 model requiring coordination of care with an array of primary care services available on site
 - Department of Behavioral Health:
 - SCDHHS announced FQHC specific billing protocol that would expands pool of billable providers
 - Department of Pharmacy:
 - Following flood damage to CCP-NW, repairs will enable addition of clinical consult space
